## Assumption of risk and release, Waiver, Discharge, Indemnity and Covenant Not to Sue for Adult Participant in ATU College Invitational Bass Tournament

This is a legally binding Assumption of Risk and Release, Waiver, Discharge, Indemnity and Covenant Not to Sue (referred to as the "Release") executed by \_\_\_\_\_ (your name), to Arkansas Tech University, Russellville, Arkansas 72801 (referred to as the "University").

- 1.0 I, the undersigned, am at least 18 years of age and otherwise fully competent to execute this Release, desire to participate in activities and field trips conducted as a part of Arkansas Tech University College Invitational Tournament (referred to as Invitational Tournament). I fully understand and appreciate there may be some dangers, hazards, and risks inherent in the Invitational Tournament, as well as in any transportation to and from the Invitational Tournament. Relying on my own judgment, I have voluntarily chosen to participate and assume any dangers and risks.
- 2.0 Knowing there may be some dangers and risks of the Invitational Tournament, and in consideration of being permitted to participate in the Invitational Tournament, on behalf of myself, my spouse, family, heirs, Administrator(s), executor(s), personal representative(s), and assigns agree to assume all the risks and responsibilities surrounding my participation in the Invitational Tournament, and release, waive, forever discharge, and covenant not to sue the University, its governing board, officers, agents, employees, and any adult or students acting as employees and/or volunteers (referred to as the "Releases"), from and against any and all liability for any harm, injury, damage, claims, demands, lawsuits, actions, causes of action, costs, and expenses of any nature that I may have or that may hereafter accrue to me, arising out of or related to any loss, damage, or injury, including but not limited to suffering and death, that may be sustained by me or by any property belonging to me, whether caused by the negligence or carelessness of the Releases or otherwise, while I am in, on, upon, or in transit to or from the premises where Invitational Tournament occurs or is being conducted.
- 3.0 I understand and agree that Releases may not have medical personnel available at the location of the Invitational Tournament or on the campus. I understand and agree that Releases are granted permission to authorize emergency medical treatment for me if necessary. I understand and agree that Releases assume no responsibility for any injury or damage which might arise out of or in connection with such authorized emergency medical treatment
- 4.0 I also agree that I have an obligation to follow all laws, safety rules, utilize all safety equipment, and agree not to engage in any disruptive behavior while participating in any activity in connection with the Invitational Tournament at Arkansas Tech University. Further, I agree not to consume or be under the influence of, alcohol or illegal drugs while participating in any activity in connection with the Invitational Tournament at Arkansas Tech University and Lake Dardanelle, Russellville, Arkansas. If I do consume, possess or am under the influence of alcohol or illegal drugs while participating in the Invitational Tournament, I agree that I will automatically be disqualified from the Invitational Tournament.

- 5.0 It is in my express intent that this shall bind the members of my family and spouse, if I am alive, and my estate, family, heirs, administrators, personal representatives, or assigns, if I am deceased, and shall be deemed as a “Release, Waiver, Discharge and Covenant Not to Sue” in favor of the above named Releases. I further agree to save and hold harmless, indemnify, and defend Releases from any claim by me or my spouse, family, estate, heirs, administrator(s), personal representative(s), or assigns arising out of my participation in the Invitational Tournament.
- 6.0 I know my physical limitations and capabilities and hereby certify that I am physically fit to engage in the activity of the Invitational Tournament, and further state that there are no health-related reasons or problems which preclude or restrict my participation in the Invitational Tournament, and that I have adequate health insurance necessary to provide for and pay any medical costs that may be attendant as a result of injury to me.
- 7.0 I agree that this Release shall be as broad as possible and shall be construed in accordance with the laws of the State of Arkansas. Further, I agree that the forum for any disputes or lawsuits arising from or incident to this Release shall be the Arkansas State Claims Commission. If any term or provision of this Release shall for any reason be held invalid, illegal, unenforceable, or in conflict with any law governing this Release, the validity of the remaining portions shall not be affected thereby, but shall continue in full legal force and effect. Nothing in Release shall be deemed to waive the sovereign immunity of the State of Arkansas, Arkansas Tech University, the Arkansas Tech University Board of Trustees, or its administrators, faculty, staff, or agents.
